Entry Details

- 2. One submission per Instagram profile is allowed. Submissions made by individuals that exceed this limit will automatically be disqualified.

Winner selection

GENERAL COMPETION RULES

These are the General Competition Rules that govern the relationship between the Council and a party entering into a competition run by the Council.

By participating in any of the Council's Competitions, you agree to be bound by these General Competition Rules (which may be amended or varied at any time by the Council with or without notice).

1. DEFINED TERMS

The following words shall have the following meanings in the General Competition Rules:

- (a) "The Council" means Perth and Kinross Council, a local authority constituted under the Local Government etc. (Scotland) Act 1994 and having its principal office at 2 High Street, Perth, PH1 5PH
- (b) "The Entrant" means the Party entering into any Competition run by the Council.
- (c) "The Supplementary Rules" means any rules which are incorporated into these General Competition Rules for a specific competition.
- (d) "Prize" means the prize identified by the Council to entrants in respect of a Competition.
- (e) "Competition" means a competition run for or on behalf of the Council

2. SUPPLEMENTARY RULES

- 2.1 All Competitions will be supplemented by Supplementary Rules.
- 2.2 Supplementary Rules will be incorporated into and form a part of the General Conditions of Competition which regulate the relationship between the Council and the Entrant.
- 2.3 The Supplementary Rules shall set out:
 - (a) the opening and closing date for a Competition;

- (b) details of all prizes for that Competition including whether any additional third party terms apply to the prizes or not;
 - (c) details of how to enter;
- (d) details of how the winner will be selected including any relevant judging criteria;
 - (e) any specific eligibility criteria that applies to that Competition;

- 3.8 These General Competition Rules do not create or infer any rights that are enforceable by any person who is not party to them.

4.1 All Prizes are non-transferable and no alternative will be offered. Arrangements for the fulfilment of Prizes will be made by the Council. If due to circumstances beyond our control we are unable to provide any stated Prize(s), we reserve the right to award a substitute Prize of equal value. All Prizes may be subject to the additional terms and conditions.

5. ELIGIBILITY

- 5.1 The Council reserves the right to require proof that an Entrant meets the eligibility requirements for any Competition. Failure to provide proof of the eligibility requirements may result in disqualification from a Competition and the forfeit of any prizes awarded.
- 6. INTELLECTUAL PROPERTY
- 6.1 By entering a Competition the Entrant grants the Council a perpetual, non-exclusive, transferable, sub-licensable worldwide and royalty free licence to use your entry, including any intellectual property rights that may subsist in your entry for the purposes of the administration and promotion of the relevant Competition.

entirely at the Entrant's own risk, provided that nothing in these General Competition Rules shall exclude the Council's liability for:

- (a) death or personal injury caused by negligence;
- (b) fraud or fraudulent misrepresentation; or
- (c) any other liability that cannot be excluded by law.

8. DATA PROTECTION

Any personal information, including without limitation, your name, age, address (including postcode), telephone number and/or email address ("Personal Data") will be used (i) in connection with the Competition which you entered, (ii) for any purpose to which you gave your express consent on entry (iii) as set out in these General Competition Rules and (iv) in accordance with our Privacy Policy. - 9.2 In the event the Council reasonably apprehends a Prize has not been used towards a specified purpose, the Council may demand the return of the Prize or, if the Prize is cash, recover the Prize as a debt.

10 JURISDICTION

10.1 These General Competition Rules shall be governed by and construed in accordance with the laws of Scotland and the courts of Scotland shall have exclusive jurisdiction in relation to any disputes arising therefrom.
